## REGULATIONS FOR THE RENTAL OF EQUIPMENT.

- a. All rented equipment must be maintained and looked after carefully and only used in accordance with the instructions given when handed over, according to what is expected and allowed by the manufacturer's stipulations. In fact it is forbidden to tamper with the equipment, use it for purposes other than that permitted by the manufacturer - as demonstrated at the briefing - and/or allow it to be used by those not adequately instructed on its correct functioning, since this could be very dangerous. In any case the user, who has been shown how to use the product, is the only person responsible.
- b. It is forbidden to use the equipment under the influence of alcohol, drugs or anything which could compromise the capacity to use the equipment correctly and lucidly.
- c. The client is obliged to declare immediately to the personnel of the Chalet delle guide "Mmove by Friends of Arco S.r.l." any possible incidents which have taken place or particular events which could have caused the malfunctioning of the equipment. The client who has responsibility must commit himself to pay the Friends of Arco S.r.l. with headquarters in Arco (TN) for repairs or purchase of the equipment entrusted to him in the case of damage, destruction, loss or theft for whatever reason, apart from cases of 'force majeure' to be proved by the responsible person himself. The costs will be calculated according to the renter's current price list, with a discount of 20 % of the cost, in the case of total loss or in the event of repairs.
- d. All the appliances and equipment are marked with an identification number and recorded on a file which stores its individual history (form on equipment info). The rental is done by electronically registering the personal data of the client and the equipment rented. The collection of this data is indispensable, apart from protecting the customer from possible theft or deficiencies, it also guarantees the safety of the rented equipment by tracking its use over time. The equipment is handed over undamaged, in perfect working order and guaranteed, while taking into account any deterioration due to use and age. The year of manufacture is visible on the label affixed to the individual parts and the guarantee is dated by the manufacturers on every single component. The client-user is therefore responsible for verifying, by looking to check its condition, together with the renter, at the moment of handing over and handing back the equipment.
- e. It is explicitly forbidden, under any circumstances, to hand over or entrust the rented equipment to third parties.
- f. The period of rental cannot in any circumstances go beyond the hand over date. The period begins on the day this form is signed and finishes on the date indicated on the rental contract. ## BENUTZERVERORDNUNG MATERIALVERLEIH.

- a. Die Ausrüstungsgegenstände müssen sorgfältig behandelt werden und dürfen nur für die vom Hersteller vorgesehenen Aktivitäten verwendet werden – entsprechende Informationen werden bei der Materialausgabe im Sinne des Herstellers erteilt. An den Ausrüstungsgegenständen dürfen keine irreversiblen Veränderungen vorgenommen werden. Da der falsche Gebrauch des Materials ein hohes Gefahrenrisiko birgt, darf das Material nur von instruierten Personen und auf die vorgesehenen Art und Weise verwendet werden.
